**ORDINANCE 2022-125**

AN ORDINANCE PROVIDING FOR A CHANGE IN THE RESIDENTIAL AND COMMERCIAL SOLID WASTE DISPOSAL COLLECTION RATES; REQUIRING POLY CART SERVICE FOR ALL CURBSIDE PICKUP; REPEALING ALL ORDINANCES OR SECTIONS IN CONFLICT THEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

SECTION 1: The section titled Solid Waste Collection Monthly Charges to read as follows:


