

Grand Saline City Council
June 13, 2023
Regular Meeting Minutes
7:00 P.M.

A regular meeting of the Grand Saline City Council was called to order at 7:00 p.m. by Mayor Ridge Tardy. The Mayor announced a quorum present with the following: Councilmember July Cato, Councilmember Brandi Morris, Councilmember Leah Lamb, and Councilmember Kathy Smith.

Invocation given by Councilmember Kathy Smith followed by the Pledge of Allegiance to the American and Texas flag.

Approve minutes of previous meetings – Councilmember Kathy Smith made a motion to approve the minutes for May 9, 2023 Council Meeting. Councilmember July Cato seconded the motion. Motion carried unanimously.


