

Grand Saline City Council
July 18, 2023
Regular Meeting Minutes
7:00 P.M.

A regular meeting of the Grand Saline City Council was called to order at 6:00 p.m. by Mayor Ridge Tardy. The Mayor announced a quorum present with the following: Councilmember Brandi Morris, Councilmember Leah Lamb, and Councilmember Kathy Smith present and Councilmember July Cato absent.

Invocation given by Jeremy Barker followed by the Pledge of Allegiance to the American and Texas flag.

Approve minutes of previous meetings – Councilmember Kathy Smith made a motion to approve the minutes for June 13, 2023 Council Meeting. Councilmember Brandi Morris seconded the motion. Motion carried unanimously.

Councilmember Brandi Morris seconded the motion. Motion carried unanimously.

Ordinance No. 2023-111 Amending Ordinance No. 2010-113 Chapter 1 Article 1.06 Sealed competitive procurements – Councilmember Kathy Smith made a motion to approve Ordinance No. 2023-111. Councilmember Leah Erwin seconded the motion. Motion carried unanimously.

Ordinance No. 2023-112 – Repeal Ordinance No. 2022-123 – Councilmember Leah Erwin made a motion approve Ordinance No. 2023-112. Councilmember Kathy Smith seconded the motion. Motion carried unanimously.

City Council Procedures and Decorum – Tabled. To be placed on the August 2023 agenda to allow the City Attorney to review them.

Approval of budget adjustments and/or transfers – Councilmember Kathy Smith made a motion placed an Ordinance for this item on the August 2023 agenda. Councilmember Leah Erwin seconded the motion. Motion carried unanimously.

Donation of signage for Council Chamber of our national motto “In God We Trust” to be placed on wall behind the Council seating area – Councilmember Leah Erwin made a motion to approve signage “In God We Trust” on the wall. Councilmember Brandi Morris seconded the motion. Motion carried unanimously.

Update on the Sale of City Lake – City Attorney advised Council that the City has to find three (3) heirs of ADean Fackler on the .95 acreage. No action taken.



Update on City property behind the Dairy Bar – Councilmember Leah Erwin made a motion to sell this property to Niki Rowan for fair market value of \$200.00. Councilmember Brandi Morris seconded the motion. Motion carried unanimously.

Update on auction of City equipment and vehicles – Dana Clair advised Council that she and Logan Craft are working on this and have to get pictures of the things to be sold. No action taken.

City Council vacant spot – Councilmember Leah Erwin made a motion to take sealed applications until August 8, 2023 for the vacant spot. Councilmember Kathy Smith seconded the motion. Motion carried unanimously.




Departmental reports were given by the Department Heads.
